

Obrigado por adquirir um processador de sinal NEXO DME10. Este produto pode processar uma ampla gama de sinais de áudio. Este Guia de Configuração explica como configurar diversas configurações básicas durante a instalação. Para garantir que você possa utilizar corretamente todas as funções do produto, leia este Guia de configuração antes de usar o produto. Depois de ler este Guia de configuração, guarde-o para referência futura.

## Características

### • Processador de sinal programável para sistemas de áudio em uma ampla variedade de aplicações

O DME10 é um processador altamente configurável que oferece funcionalidade sofisticada e áudio de excelente qualidade para uso em uma ampla variedade de aplicações. Além da funcionalidade básica de mixagem de matriz, equalização, delay, compressor e gate, ele também inclui muitos componentes que oferecem suporte a uma variedade de aplicações, como aplicativos de mixagem automática e combinador de salas. Ele também suporta sistemas de áudio de grande escala com 256 × 256 canais de entradas e saídas Dante.

## Precauções para a montagem em suporte

---


A faixa de temperatura operacional garantida para o produto é de 0 a 40 °C. Se você estiver montando apenas unidades DME10, várias unidades podem ser montadas e operadas em um rack EIA padrão sem deixar espaço entre as unidades. Se o DME10 for montado em um rack EIA padrão junto com outros dispositivos, o calor gerado por esses dispositivos pode afetar negativamente o desempenho devido às temperaturas elevadas dentro do rack. Para evitar que o calor se acumule no interior do produto, certifique-se de montar os produtos de uma forma que satisfaça as seguintes condições.

- Se for montado junto com um amplificador de potência ou outros dispositivos que tendem a gerar calor, deixe pelo menos uma unidade de espaço entre o produto e os outros dispositivos. Além disso, para garantir ventilação adequada, instale um painel ventilado nesses espaços ou deixe o espaço aberto.
- O DME10 foi projetado para aspirar ar pela frente e expulsá-lo pela traseira. Conseqüentemente, você não deve instalar o DME10 junto com outros dispositivos que captam ar pela parte traseira e o expõem pela parte frontal.
- Deixe a parte traseira aberta e posicione o suporte a pelo menos 10 cm de distância de qualquer parede ou teto. Se a parte traseira do suporte não puder ser deixada aberta, utilize um kit de ventilador disponível comercialmente ou outro sistema de ventilação forçada. Se for instalado um kit de ventilador, note que o enclausuramento da parte traseira do suporte pode melhorar a dissipação de calor em alguns casos. 

## Preparação e processamento de fios de cabos

Descasque o cabo a ser conectado ao conector Euroblock conforme mostrado abaixo e conecte os fios condutores. Observe que a sobreposição ou vibração dos fios conectados ao Euroblock pode causar a quebra do fio condutor devido à fadiga do metal.




### Cuidado


Se o Euroblock estiver conectado usando fios condutores, não solde os fios.

Se os fios forem frequentemente desligados e ligados, recomenda-se a utilização de terminais de pinos com uma manga de isolamento. Utilize conectores de pinos como o mostrado abaixo.


Utilize um modelo com diâmetro de até 1,3 mm e comprimento de cerca de 5 mm (como o modelo AI0, 5-6WH da Phoenix Contact).



1. Insira o conector Euroblock no conector [GPI] principal até que este encoste ao outro extremo. Em seguida, empurre a trava para cima nos lados esquerdo e direito.



2. Para desligar os conectores Euroblock, baixe os bloqueios dos lados esquerdo e direito e puxe o conector para fora.



## Conectando a fonte de alimentação



### Advertências

Utilize sempre o cabo de alimentação fornecido com o produto. Não utilize o cabo de alimentação fornecido para outros produtos. Isso pode resultar em falha, geração de calor, incêndio ou outros problemas.



### Cuidado


1. Ligue o cabo de alimentação fornecido. Primeiro conecte o cabo de alimentação à unidade principal e depois conecte-o a uma tomada elétrica.

### OBSERVAÇÃO

- Para desligar o cabo de alimentação, inverta os passos acima indicados.
- Pressione o trinco do cabo de alimentação para desligar o cabo de alimentação.

## Ligar/desligar a energia

1. Use o botão liga/desliga no painel traseiro para LIGAR (I) ou DESLIGAR a energia (⏻).




### AVISO

- Ligar e desligar o interruptor de energia rapidamente em seqüência pode causar mau funcionamento da unidade. Após desligar o interruptor de energia, aguarde pelo menos seis segundos antes de ligá-lo novamente.
- Uma pequena quantidade de corrente continuará fluindo mesmo quando a energia estiver desligada. Certifique-se de desconectar o cabo de alimentação da tomada se a unidade não for usada por um longo período de tempo.

## Instalando o gancho para o cabo


Um gancho de cabo é fornecido para evitar a desconexão acidental do cabo USB. Para prender o gancho do cabo, siga os passos abaixo.

1. Prenda uma extremidade do gancho para o cabo incluído na extremidade inferior da ranhura de segurança, localizada na área inferior esquerda do painel traseiro.




2. Insira a outra extremidade do gancho na extremidade superior do slot de segurança.

3. Insira o cabo USB no gancho e depois conecte-o à porta USB.



## Configurações da unidade principal

### Visão geral do painel frontal



#### 1 Indicador [A/B]

O indicador [A/B] mostra se os terminais [A]/[B] AC IN (entrada de alimentação) estão conectados à energia. Acende-se a verde quando a alimentação está ligada.

#### 2 Tecla [Fn]

Pressione a tecla [Fn] para exibir a tela [Device Mute]. Pressione novamente para exibir a tela [Control Function].

#### 3 Tecla [MENU/HOME]

Pressione a tecla [MENU/HOME] para alternar entre as telas [Menu] e [Home].

#### 4 Tecla [↶] (retroceder)

Pressione a tecla [↶] (retroceder) para exibir a tela anterior.

#### 5 Botão principal

Gire o botão principal para selecionar parâmetros ou alterar os valores de configuração dos parâmetros. Pressione o botão para aplicar a configuração.

### Preamble

The GNU General Public License is a free, copyleft license for software and other kinds of works.

## Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.
