

### **ПРЕДУПРЕЖДЕНИЕ**

Всегда соблюдайте основные меры предосторожности, перечисленные ниже, чтобы избежать получения серьезных травм или даже летального исхода в результате поражения электрическим током, короткого замыкания, повреждений, пожара или других опасностей. Эти меры предосторожности включают, помимо прочего, следующее:

### Нештатные ситуации

- При возникновении любой из указанных ниже проблем немедленно отключите питание выключателем и отсоедините штепсельную вилку от розетки.
  - Износ или повреждение кабеля питания или штекера.
  - Появление необычных запахов или дыма.
  - В изделие попали посторонние предметы или вода.
  - Во время эксплуатации изделия внезапно пропадает звук.
  - Трещины или другие видимые повреждения на изделии. Затем передайте изделие для осмотра или ремонта специалистам центра технического обслуживания NEXO.

### Источник питания

- Не располагайте кабель питания рядом с источниками тепла, например обогревателями или радиаторами, и не допускайте чрезмерного сгибания или повреждения кабеля другим способом, не ставьте на него тяжелые предметы и не держите его в таком месте, где кто-либо может на него наступить, задеть ногой или что-либо по нему перекатить.
- Используйте только напряжение, соответствующее изделию. Нужное напряжение указано на табличке изделия.
- Используйте только прилагаемый или указанный кабель питания/вилку.
  - Если изделие будет использоваться в другом регионе, чем тот, где оно куплено, прилагаемый кабель питания может не подойти. Свяжитесь с региональным дилером NEXO.
- Не используйте комплектный кабель/вилку с другими изделиями.
- Периодически проверяйте штепсельную вилку и очищайте ее от накопившейся пыли или грязи.
- Для предотвращения поражения электрическим током или возникновения пожара полностью вставляйте штепсельную вилку в розетку.

• Данное изделие получает питание из нескольких





источников. При установке изделия убедитесь в том, что используемая сетевая розетка легкодоступна. При возникновении проблемы или неисправности немедленно выключите выключатель питания и отсоедините все вилки от розеток. Даже если выключатель питания находится в выключенном положении, до тех пор, пока кабель питания не отключен от сетевой розетки, изделие остается подключенным к источнику питания.

- Выньте штепсельную вилку из розетки, если изделие не будет использоваться в течение длительного времени.

### Не открывать

### Беречь от воды

- Не допускайте попадания изделия под дождь, не пользуйтесь им рядом с водой, также в условиях сырости или повышенной влажности, а также не ставьте на него емкости (например, вазы, бутылки или стаканы), содержащие жидкости, которые могут пролиться и попасть в отверстия.

### Беречь от огня

 Не размещайте горящие предметы или открытый огонь рядом с изделием, поскольку это может привести к возгоранию.

### Потеря слуха

- Перед подключением изделия к другим устройствам отключите питание всех устройств. Также перед включением или выключением питания всех устройств убедитесь, что все регуляторы громкости установлены на минимальное значение. В противном случае это может привести к потере слуха, поражению электрическим током или повреждению устройства.
- При включении питания переменного тока в аудиосистеме всегда включайте усилитель мощности ПОСЛЕДНИМ, чтобы избежать потери слуха и повреждения динамиков.
   При выключении питания усилитель мощности следует выключать ПЕРВЫМ по той же причине.

### Батарея

 Зарядка должна осуществляться в пределах установленного температурного диапазона для зарядки.
 Зарядка при температуре, выходящей за рамки этого диапазона, может привести к утечке, перегреву, взрыву или повреждению устройства.

- Не бросайте батарею в огонь.
  - Не подвергайте батарею воздействию крайне низкого атмосферного давления, холода или тепла (например, под прямым солнечным светом или возле огня), чрезмерной пыли или влажности.
  - Это может привести ко взрыву батареи и стать причиной пожара или травмы.
- Не разбирайте батарею. Несоблюдение этого требования может привести к возгоранию, перегреву, взрыву или неисправности. Попадание содержимого батареи на руки или в глаза может вызвать слепоту или химические ожоги.


## Меры предосторожности при монтаже в стойку

Работоспособность изделия гарантируется в диапазоне температур 0–40 °C. Если в стандартную стойку EIA устанавливаются только устройства DME10, можно установить и эксплуатировать в стандартной стойке EIA несколько модулей, не оставляя пространства между ними. При установке DME10 совместно с другими устройствами в стандартную стойку EIA тепло, выделяемое каждым устройством, может повысить температуру внутри стойки и отрицательно повлиять на производительность. Для предотвращения накапливания тепла внутри изделия соблюдайте следующие условия при монтаже изделий.

- Если данное изделие устанавливается вместе с усилителем мощности или другими устройствами, выделяющими тепло, следует оставить пространство в размере не менее одного блока между данным изделием и другими устройствами. Кроме того, установите вентилируемую панель в образовавшееся свободное место или оставьте его открытым, чтобы обеспечить достаточную вентиляцию.
- DME10 спроектирован таким образом, что забирает воздух спереди и выпускает сзади. Поэтому не следует устанавливать DME10 вместе с другими устройствами, которые забирают воздух сзади и выпускают его спереди.
- Оставьте заднюю панель стойки открытой и расположите стойку на расстоянии не менее 10 см от любой стены или потолка. Если заднюю панель стойки нельзя оставить открытой, необходимо установить дополнительно приобретаемый комплект вентилятора или другую систему приточной вентиляции. Если установлен комплект вентилятора, закрытие задней панели стойки может улучшить отвод тепла в некоторых случаях. 
### Установка штекеров Euroblock

Используйте штекеры Euroblock, входящие в комплект поставки, для подключения к разъемам [GPI].



### Подготовка и обработка кабельных проводов

Зачистите конец кабеля для соединения со штекером Euroblock, как показано ниже, и подключите питающие провода. Следует иметь в виду, что перекрытие или вибрация кабелей, соединенных со штекером Euroblock, может привести к поломке питающего провода из-за усталости металла.





#### Внимание


При подключении Euroblock с использованием питающих проводов не покрывайте провода припоем.

Если провода необходимо часто отключать и переподключать, рекомендуется использовать штырьковые выводы с изолирующей оболочкой. Используйте штыревые соединители, аналогичные показанному ниже.


Используйте модели диаметром до 1,3 мм и длиной около 5 мм (например, модель Phoenix Contact Al0, 5-6WH).



1. Введите штекер Euroblock в главный разъем [GPI] целиком, чтобы его концы уперлись в противоположную сторону. Затем поднимите блокиратор слева и справа.



2. Чтобы отключить штекеры Euroblock, опустите блокираторы слева и справа и вытяните штекер.



### Подключение источника питания



### Предупреждение






## Установка держателя для кабеля

Держатель для кабеля предназначен для предотвращения случайного отключения USB-кабеля. Для прикрепления держателя для кабеля выполните приведенные ниже пункты.

1. Зацепите один конец держателя для кабеля, входящего в комплект поставки, за нижний конец защитного замка, который находится в левом нижнем углу задней панели.



### ① Индикатор [A/B]

Индикатор [A/B] показывает, подключены ли разъемы [A]/[B] AC IN (вход источника питания) к источнику питания. Когда питание включено, он горит зеленым светом.

### ② Кнопка [Fn]

Нажмите кнопку [Fn] для отображения экрана [Device Mute]. Нажмите ее еще раз для отображения экрана [Control Function].

### **③ Кнопка [MENU/HOME]**

Нажимайте кнопку [MENU/HOME] для переключения между экранами [Menu] и [Home].

Появится экран [Unit ID].



2. Находясь на экране [Unit ID], нажмите основной регулятор, чтобы активировать режим редактирования.



3. Поверните основной регулятор, чтобы выбрать желаемый код.

Когда код устройства меняется, значение мигает. Диапазон значений составляет от 01 до FE в шестнадцатеричной системе исчисления.

**4.** Когда выбран код устройства, который вы хотите изменить, нажмите основной регулятор.

Появится сообщение о необходимости перезагрузки устройства.




5. Поверните основной регулятор для выбора варианта [Yes], затем нажмите регулятор, чтобы применить настройку.

Новый код устройства будет активирован после перезагрузки устройства.







### Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software—to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price.
